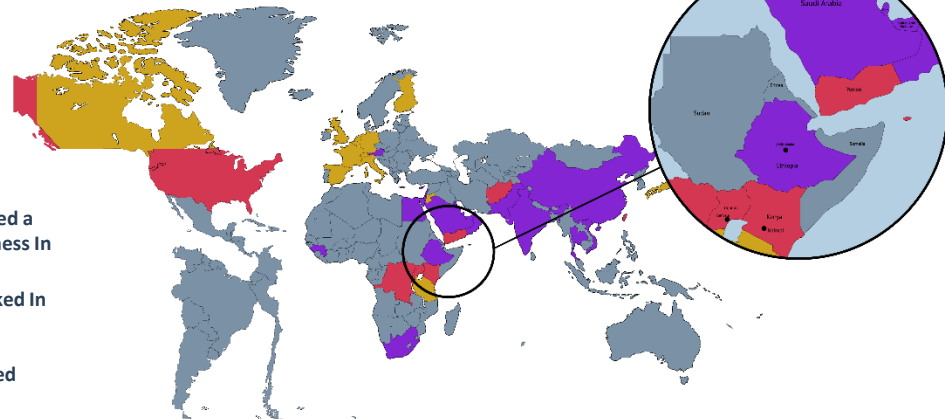

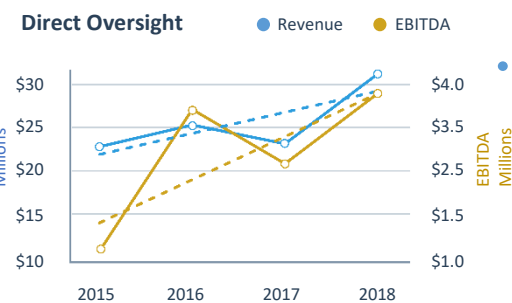

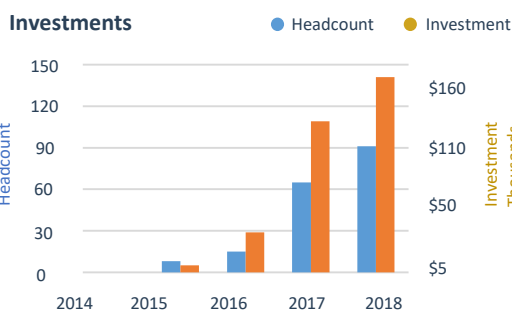
## Brands Under Distribution



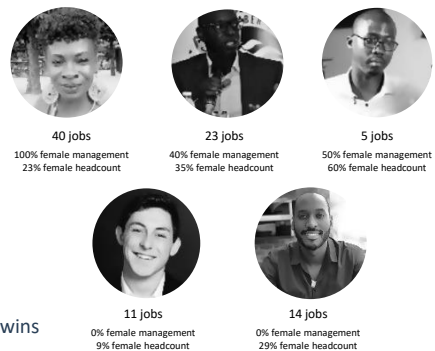

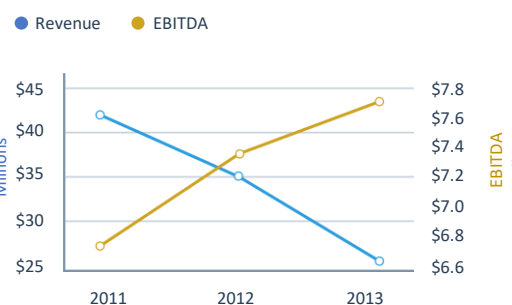
